## A COMPLETED WAIVER IS REQUIRED TO BOOK A STAY AT GRENADA LAKE LODGING

### Lodging

### THERE ARE NO EXCEPTIONS!

In consideration of being allowed to book a stay at Grenada Lake Lodging, the undersigned, on his or her own behalf and on behalf of the minor(s) identified below, acknowledges, appreciates and agrees that:

1. You represent that you are 18 years of age or older. If you are bringing a minor as a Guest, you acknowledge and agree that you are solely responsible for the supervision of that minor throughout the duration of your stay, and have read this Waiver and agree to it on the minor's behalf. If you are booking a stay on behalf of other Guests, you will ensure, and you represent and warrant, that each Guest on whose behalf you book has read and agreed to this Waiver, which shall apply to each of them as if the reference to "you" was a reference to him/her.
2. You are a visitor to and renter of a property commonly known as Grenada Lake Lodging (the "Property"), and You acknowledge and agree:
  - a. I am aware that my stay involves risks that may result in serious bodily injury and/or death. Some of the risks include, but are not limited to, drowning, falling, sports injury, slips, trips, falls, cuts, adverse weather conditions, the acts or omissions of guests or visitors on the Property during my stay, and the condition of the Property. I understand that the description of the risks in this "Waiver" is not complete and that other risks or events that are known or unknown, anticipated or unanticipated may result in serious bodily injury and or/death.
  - b. In consideration of being permitted to rent and stay at Grenada Lake Lodging, I agree on my own behalf, my family, any and all guests, and invitees that I am fully responsible for any and all risks of injury or death. I hereby release and hold harmless Grenada Lake Lodging, and its members, principals, agents, officers, employees, and representatives (collectively "Releasees") as well as the owner of the Property.
  - c. I agree to fully and forever release and discharge, and not to sue Releasees for any injuries or damages, including bodily injury or property damage that may result from or be related in any way to my rental and stay at the property. I further agree to indemnify and defend Releasees, through their own choice of counsel, against any and all claims arising out of or related in any way to my rental of the Property, including claims by third parties.
  - d. BY RENTING ONE OF THESE PROPERTIES DIRECTLY FROM THE OWNERS AND/ OR THROUGH A THIRD PARTY, I ACKNOWLEDGE THAT I HAVE READ THIS ENTIRE "Waiver" AND THAT I UNDERSTAND ITS TERMS AND AGREE TO BE BOUND BY THEM. I UNDERSTAND THAT THIS "Waiver" SHALL BE EFFECTIVE AND BINDING UPON ME, MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVE, ESTATE, AND ALL MEMBERS OF MY FAMILY, MINORS, INVITEES, AND OTHERS IN MY CARE, CUSTODY OR CONTROL, AND AGREE TO ADVISE ALL SUCH INDIVIDUALS OF THIS "Waiver" AND CAREFULLY SUPERVISE THEIR USE OF PROPERTY.
